## 2023 Mid-Year Distributions

If you have selected reinvestment, the distributions will be reinvested as additional shares into the fund at the day's closing price.

<u>Reinvestment Date</u> – If you have selected reinvestment, the distributions will be reinvested as additional shares into the fund at the day's closing price.

<u>Payable Date</u> – If you have not selected reinvestment, the distributions will be paid on this date.
